Frames must be gallery quality, wired, ready to hang, no unframed  
work will be accepted.

### **Special Note**

The Exhibition Committee would prefer that members submit the  
actual art for review by the juror. However, the member may submit  
35mm slides or digital images (several views please) on a CD for  
review by the juror. The slides or digital images must be of the best  
quality available. If submitting by slide or disc, they must be identi-  
fied per Exhibition Rules (see above). Slides or discs along with entry  
forms and a check for entry fees may be mailed to the PSA P.O. Box.  
The P.O. Box will be checked for entries Friday, February 15. Any  
entries received at the P.O. Box after February 15 will not be present-  
ed to the juror. Slides or discs may be delivered to Brand Library  
Recital Hall during listed drop-off hours on Saturday, February 16.

Juror announcement forthcoming along with directions to the Brand  
Library Art Galleries and the loading dock located a short distance  
from the Recital Hall.

All accepted artwork will remain in storage at the Brand Library Art  
Galleries until the 83rd Annual Exhibition opens.

All work will be photographed with 35mm slide film for use in  
future PSA proposals, presentations and the website.
